# 1.1. Metering ICF Package

Date of Notice: 20 May 2019

This notice informs all Registered Participants, Metering Providers, Metering Data Providers, Embedded Network Managers, Ministers and the AER (**Consulted Persons**) that AEMO is conducting a consultation on various metering procedures to implement recommended process improvements from proponents and AEMO and updates to various metering procedures to align the procedures with changed rule references.

This consultation is being conducted in accordance with the Rules consultation requirements detailed in Rule 8.9 of the NER.

# Matter under Consultation

The matter for consultation involves changes to various metering procedures to implement changes based on change proposals from industry and AEMO proponents and updated rule references. In your submission, you may request a meeting with AEMO to discuss the matter under consultation, stating why you consider a meeting is necessary or desirable.

If appropriate, meetings may be held jointly with other Consulted Persons. Subject to confidentiality restrictions, AEMO will generally make details of matters discussed at a meeting available to other Consulted Persons, and may publish them.
