# 1.1. Settlements Residue Auction Rules – Secondary Trading Implementation

Date of Notice: 23 April 2019

This notice informs all National Electricity Market Registered Participants, Intending Participants and interested parties (Consulted Persons) that AEMO is conducting a consultation on amendments to the Settlement Residue Auction Rules (Auction Rules). These amendments are to clarify definitions and clauses that have been identified while developing the systems to implement secondary trading in the Settlements Residue Auction (SRA) under the National Electricity Rules (NER).

This consultation is being conducted under clause 3.18 of the National Electricity Rules (NER), in accordance with the Rules consultation requirements detailed in rule 8.9 of the NER.

#### Matter under Consultation

The matter for consultation is amendments to the Auction Rules and associated agreements to incorporate secondary trading as contemplated in NER 3.18.3A. Further details are provided in the Consultation Paper published with this notice. A consultation draft of the Settlement Residue Auction Rules is published with this notice and the Consultation Paper.

#### Invitation to Make Submissions

AEMO invites written submissions on the matter under consultation, including any alternative or additional proposals you consider may better meet the objectives of this consultation and the national electricity objective in section 7 of the National Electricity Law.

Please identify any parts of your submission that you wish to remain confidential, and explain why. AEMO may still publish that information if it does not consider it to be confidential, but will consult with you before doing so.

Please note that material identified as confidential may be given less weight in the decision-making process than material that is published.

### Meetings

In your submission, you may request a meeting with AEMO to discuss the matter under consultation, stating why you consider a meeting is necessary or desirable.

If appropriate, meetings may be held jointly with other Consulted Persons. Subject to confidentiality restrictions, AEMO will generally make details of matters discussed at a meeting available to other Consulted Persons, and may publish them.
