### AEMO Competition Law Meeting Protocol



AEMO is committed to complying with all applicable laws, including the Competition and Consumer Act 2010 (CCA). In any dealings with AEMO regarding proposed reforms or other initiatives, all participants agree to adhere to the CCA at all times and to comply with this Protocol. Participants must arrange for their representatives to be briefed on competition law risks and obligations.

Participants in AEMO discussions must:

- 1. Ensure that discussions are limited to the matters contemplated by the agenda for the discussion
- 2. Make independent and unilateral decisions about their commercial positions and approach in relation to the matters under discussion with AEMO
- Immediately and clearly raise an objection with AEMO or the Chair of the meeting if a matter is discussed that the participant is concerned may give rise to competition law risks or a breach of this Protocol

Participants in AEMO meetings must not discuss or agree on the following topics:

- 1. Which customers they will supply or market to
- 2. The price or other terms at which Participants will supply
- 3. Bids or tenders, including the nature of a bid that a Participant intends to make or whether the Participant will participate in the bid
- 4. Which suppliers Participants will acquire from (or the price or other terms on which they acquire goods or services)
- 5. Refusing to supply a person or company access to any products, services or inputs they require

Under no circumstances must Participants share Competitively Sensitive Information. Competitively Sensitive Information means confidential information relating to a Participant which if disclosed to a competitor could affect its current or future commercial strategies, such as pricing information, customer terms and conditions, supply terms and conditions, sales, marketing or procurement strategies, product development, margins, costs, capacity or production planning.

### Program update and current activities



#### AEMO program

- Overall Green, MDM Go-Live and associated milestones have been rebaselined, re-planning activity is now complete.
- The Program is now entering a critical few months of delivery, with a large number of build items to be delivered across all workstreams
- Severe weather event has impacted the TCS Kolkata teams in addition to COVID-19.

#### Systems

- Staging environment has been updated with the 3<sup>rd</sup> Settlements drop and 2<sup>nd</sup> Dispatch drop on 15 May.
- Replanning for Retail is complete. The program is on track to deliver to the two upcoming Staging deployment dates.
- r39 Schema discussion held with market participants, understanding of n-1 requirement conveyed to participants.




#### Readiness

- Deferral scenario, incorporating MDM milestone shifts discussed with TFG, RWG and ITWG,
- Readiness Report # 2 results published. Round 2 has seen increase in response rate from participants. Follow up with participants who have indicated program issues to understand remediation requirements

### Proposed Changes to Settlements and Bidding Go-Live

• At PCF#21 AEMO proposed bringing the Settlements and Bidding Go-Lives forward.

### <u>Rationale</u>

- This was proposed as a risk mitigation measure for the following risks:
  - The risk of three significant cutovers all in a similar time
  - The solution going first (Retail) carries the most technology risk
- Both solutions are tracking on schedule for deployment into pre-production in November 2020. If the software is ready to be deployed and all entry criteria to deployment is met, AEMO should look to deliver the changes and close down program streams.
- AEMO sought feedback from the PCF and RWG on the proposed changes (next slide)

### Next Steps

- AEMO has reviewed all feedback and has continued discussions internally to consider the impact on the AEMO business
- There have been a number of risks identified with bringing the solutions forward e.g. proximity to other scheduled AEMO activities and resourcing constraints
- Therefore, AEMO is not proposing to change the date for the Settlements and Bidding Go-Live milestones. They will remain, as scheduled, on 01-Apr-21
- However, AEMO is proposing to add the risk of having three major go-lives in close proximity to the Industry Risks and Issues Register

3	Does the proposal to bring forward the implementation of the 5MS bidding platform to November impact your 5MS program?	<ul> <li>Three responded "no impact" and one indicated the proposed testing timeframes were not suitable as work on their delivery is on hold, pending the rule change deferral decision.</li> <li>A further two comments agree with the proposal: <ol> <li>No issue with bringing it forward, and</li> <li>It's desirable to have the environment available in Nov 2020 for testing purposes.</li> </ol> </li> <li>Several additional questions and suggestions were made about the approach for AEMO to consider and respond to.</li> </ul>
4	What other changes to the proposed deployment timeframe would assist in mitigating any impacts?	<ul> <li>Three responded with no impact or anything further to add. # Pre-Prod & Environment Questions

Numerous



Can AEMO open up B2B testing before the pre-Prod date of 01/02/21?

*Is AEMO considering having two pre-production environments? One for 30 min. One for 5 min?* 

How does AEMO intend to manage BAU operations in the pre-production environment? How will AEMO test regular updates to EMMS and CMS releases?

- NEM12 can be used for 5-min testing now.
- The BAU Pre-Prod environment will remain as the environment for BAU operations. As per current process, AEMO will continue to push Production-ready software into Pre-Prod a minimum of four weeks in advance of the Production deployment.
- AEMO is considering various options surrounding upgrading the capability in Staging to support MDM participant testing, 5-min support during the transition and other upcoming industry initiatives like WDR.



Does AEMO intend to maintain the current milestones and deliver all 5-min capability into the pre-production environment on 1 July 2021?

• The pre-Prod dates of deployment are as per the schedule, and yes 5min functionality is to be in pre-Prod **by** 1 July 2021. However this may be pushed back in the instance of the 12-month deferral rule change in which options will be discussed with participants (i.e. it may be desirable for the pre-Prod environment to remain in the Transition state for a longer period).



If the rule change request to defer 5-min settlements by 12 months is approved, how is AEMO intending to handle pre-production environment in terms of BAU?

- <u>Dispatch</u>: The Bidding Service has been built to accept bids as 5-min bids but runs a check during transition until 5MS rule commencement. Participants will need to be mindful that during the transition phase when submitting 5-min bids they need to emulate a 30-min bid. Staging is currently available for 5-min bidding, and only 5-min bidding. Optionality within the transition period will be the subject of a Dispatch Focus Group on 29 June 2020.
- <u>Settlements:</u> The Engine will be capable of both 30-min and 5-min Settlements and will be so from the Pre-Prod deployment in Q1 2021. However the data will only be as per the most recent Production refresh, therefore only 30-min invoicing will be produced. AEMO is investigating increasing capability and capacity of the Staging environment to better support 5-min invoicing and reconciliation throughout the transitional period, and will develop these further after the AEMC has made their decision on the 5MS Go Live 12-month Deferral Rule Change.
- <u>Retail:</u> AEMO will Release all 5MS and GS functionality into Pre-Prod however some functionality will not be made available to participants until a later time (e.g. UFE Reports will only be enabled with 5MS Go Live). Participants will be granted the required authorization to UFE reports in Pre Production for testing at a later time to be advised. There will also be 2-3 items related to CR Processing and NMI Standing Data changes (e.g. New CR rejection logic for CNDS Suffix and Type) that will only be available in Pre-Prod one month prior to 5MS and GS Production Go-Live dates respectively. Participants will be exposed to all this functionality in the 5MS Staging environment from September 2020.



Does AEMO have different bidding platforms – one for 30 min, one for 5 min?

- Yes, there are effectively two bidding platforms, one 30-min and one 5min, during transition.
- In Staging, Participants can only submit 5-min bids. 30-min bids can still be submitted in Pre-Prod <u>after</u> the transition deployment via the normal service.
- Note the Dispatch engine, already at 5-min, will remain so throughout. Pricing output will be at 30-min intervals throughout the transition, until the 5MS Market Go Live.




### Dispatch Submission Methods – Pre-5MS



- Participants submit text files via FTP (dropping a file in the Participant file server)
- In emergencies, they can submit these via the web (30-min)
- Smaller participants can use the web (30-min) to submit single bids.




### **Dispatch Submission Methods - Transition**

- Industry Testing and Market Trials Strategy: Updated in line with MDM deferral
- Feedback sought on the recommended testing approach for platform deployments
- Participants requested to nominate requirements for the proposed test approach to ensure industry testing can confidently be conducted

### Next Steps

- All feedback from all working groups has been reviewed and discussed.
- Key areas for improvement across all working groups:
  - Timelines consistency and clarity
  - Timeliness of packs and minutes
    - Currently we publish the minutes once they have been approved by the Working Group which means that they do not appear on the website for at least a month after the meeting or in the case of the Executive Forum, 3 months.
    - PCF agreed to publish the minutes as draft on the web when we circulate to the Working Group / Forum
    - Each member still has the opportunity to seek to amend and we can republish with any agreed changes
  - Packs will be circulated as .ppt and published as pdfs
  - Alignment of information across working groups
    - As the AEMO systems deployment progresses, AEMO and participants are becoming more focused on readiness activities. AEMO is undertaking a review of the working group structure to identify a more streamlined approach to disseminating information for this phase of the program and facilitating focused discussions with the appropriate experts on the call.
    - This approach will also aim to provide an improvement in the consistency and clarity of the timelines and to reduce duplication.

### Proposals

- AEMO considers that taking an end-to-end systems / readiness view at working groups will better inform and equip participants with their readiness as well as streamline information and reduce duplication.
- **Proposal:** RWG be expanded to include SWG members and agenda adjusted to provide a more integrated end-to-end view. SWG would be retained and used as a focus group for specialist technical discussion on an ad-hoc basis.
- For each Go-Live discussions will include:
  - Update on AEMO systems developments (until complete)
  - Update on AEMO preparation for deployment into pre-prod
  - AEMO and Participant preparation for market testing in pre-prod
  - AEMO and Participant preparation for go-live
- **Proposal:** Use SWG timeslot to allow 2 week gap between PCF and RWG for better flow of information.

## SWG Terms of Reference

#### Purpose

• A forum for AEMO to inform and consult with industry stakeholders *during AEMO's IT system development* to support 5MS and GS implementation.

#### Scope

- Contribution to the identification of risks and issues from a systems perspective.
- AEMO's systems development that impacts industry stakeholders for:
  - Bids and Offers
  - Settlements and Prudentials
  - Metering
  - Other areas impacted by the introduction of 5MS as required

#### Current context

- The AEMO Internal Systems Development Build Complete and the final drop into the 5MS Staging Environment are on track for completion by 31-Aug-20 meaning that the purpose and scope of the SWG is near completion
- Post 31-Aug-20, AEMO systems workstream will turn its attention to preparing systems deployment into the pre-production environment where it will be available for participant testing.

### Will anything else change?

- PCF to remain on a monthly basis with same scope
- Focus Groups will still be used as needed e.g. to discuss specific technical topics or readiness issues

### Objectives

- Allow all Participants to confirm connectivity of their test environments with the AEMO 5MS Staging Environment.
- Allow MDPs to confirm that MTRD CSV MDFF created by their systems for NEM Settlements and TUOS billing are able to pass new AEMO validations for NEM13 and NEM12 (30 min, 15 min and 5 min).
- Allow MDPs to confirm that MDMT CSV MDMF created by their systems for NEM Settlements are able to pass AEMO validations for Basic, Interval and Profile meters.
- Allow MDPs to validate FTP or API message exchange with the NEMMCO participant ID for MTRD and MDMT MeterDataNotifications.
- Allow Participants to confirm AEMO ingested meter reads


### B2M MTRD .ac1 and .ack Schema versions

### For B2B MTRDs:

- AEMO must send to the initiating participant a positive Acknowledgement in the initiating participant's preferred schema version.
- AEMO must send to the initiating participant a Hub Acknowledgement or Negative Acknowledgement in the same version of the schema as the received Message.

For B2M MTRDs:

• AEMO shall send to the initiating participant Hub Acknowledgements, Negative Acknowledgement, and Positive Acknowledgement in the same version of the schema as the received Message.

### B2M MTRD Inbox/Outbox processes

Inbox:

• AEMO shall always accept B2M MTRD messages for the NEMMCO participant regardless of the number of unacknowledged in a participant's outbox.

### Outbox:

- For MTRD messages, there are now 2 Outbox locations where a MTRD can be placed:
  - B2B outbox file share containing:
    - B2M MTRD messages delivered to it via MDM
    - B2B MTRD messages delivered to it via SMP
  - B2B Hub Queue containing:
    - B2M MTRD messages delivered to it via MDM
    - B2B MTRD messages delivered to it via SMP
- For B2M MTRD Files delivered by AEMO to a participant's outbox file share:
  - Where the number of B2M MTRD messages delivered to the participant's outbox file share is below 100, AEMO delivers B2M MTRD responses (transaction acknowledgments).
  - Where the number of B2M MTRD messages delivered to the participant's outbox file share is equal to the 100, AEMO will stop delivering messages.

## B2M MTRD and B2B Stopfiles

### It is proposed that the count of B2M MTRD messages:

- In the Outbound file share will not contribute to B2B stopfile count
- In the Outbound Queue will not contribute to the B2B stopfile count

### Considerations:

- AEMO wishes to ensure that stopping a Participant due to an issue with their B2B systems should not stop them being able to receive messages for their B2M MDM system and vice versa.
- Clear distinction between B2M MTRD and B2B MTRD for the purpose of stopfiles.
- Where a B2B stopfile is placed, when an FTP participants is clearing out their B2B outbox, they need to understand that the B2M MTRD files they find there don't contribute to their stopfile count.
- The delivery behaviour of B2M MTRD files to the participants outbox file share may be a source of confusion as the EMDM will continue to deliver while the participant is stopped. For example, if a stopped participant starts acknowledging B2M MTRDs from their outbox file share, where B2M MTRDs remain undelivered in the MDM Outbound Queue, the MDM will continue topping up the outbox file share with new files.
