#### PRELIMINARY MATTERS

#### 1.1 Apologies

Meghan Bibby (AEMO) welcomed the B2B Working Group (B2B-WG) to the first meeting of 2021. Apologies were received from Stephanie Lommi (Alinta). Wayne Farrell (Yurika) entered late due to technical difficulties.

### 1.2 Confirm agenda

The B2B-WG confirmed the agenda. Michelle Norris (AEMO) provided an IEC update and noted that if the Northern Territory adopt a NT version of the NER, there may be a need for a NT representative on the IEC. It is also possible a dual consultation for B2B procedures would need to be run for the NEM and for the NT.

Mark Riley (AGL) noted that AEMO proposed several changes to the NER consultations process in rule change. AEMO confirmed that a verbal update on this rule change will be provided at a later date.

Actions:

- Meghan Bibby and Jordan Daly (AEMO) to request AEMO look at providing an industry overview session on how the NER consultation process will flow as per AEMO's procedure consultation rule change proposal.
- Meghan Bibby and Jordan Daly (AEMO) to provide a summary of B2B changes for the Working Group

# **ITEMS FOR DISCUSSION OR NOTING**

# 2.1 Life Support – None - Mark Riley (AGL)

Mark Riley (AGL) has drafted processes for churn and reconciliation, aiming to make the secondary processes identical to minimise change for participants. Recommends inclusion in the Guide.

Actions:

• Mark Riley (AGL) to update diagram to reflect the 'No' flow for LSN=None question and recirculate diagrams to B2B-WG.

• Distributors to compare Mark's Life Support 'None' process to their own internal processes to assess combability (led by Dino).

## 2.2 Name Title ICFs – Joe Castellano (Origin)

Joe Castellano (Origin) spoke to his NameTitle ICFs. They propose the ASWG manage the list but there is an initial consultation to confirm this. David Woods (SAPN) asked how a participant would find the latest version of the list of valid titles if not the Australian Standards – the ASWG need to explicitly state which elements are available. Shaun Cupitt (Alinta) also asked what the ASWG change process is as it's unclear.

Actions:

- B2B-WG members to look into the <u>ASWG change process</u> and whether it's suitable for the NameTitle ICFs.
- Joe Castellano (Origin) to tweak NameTitle ICFs regarding responsibility for updating and maintaining the list and submit documents to the IEC.
- B2B-WG members to look into other fields tied to an AS with an enumerated list and how to ensure they're kept up to date.
- Mark Riley (AGL) and David Woods (SAPN) to map out the process of managing the respective lists and the Technical Specifications with respect to updating the ICF and accommodating for the ASWG change process.

## 2.3 NotifiedParty Consultation

Meghan Bibby (AEMO) spoke to the IEC discussion that occurred on 17 December 2020. AEMO to manage the cost/benefit analysis to ensure confidentiality and competition issues are avoided. The IEC noted that it wants the cost/benefit information to ensure the change is appropriate for industry. The B2B-WG discussed which jurisdictions should be included in the request for cost/benefits and questioned whether it should it be:

- limited to jurisdictions where remote services can be utilised, or
- cover all jurisdictions given B2B Procedure changes may have future impacts. (

The WG also discussed consultation timings, in particular ff a consultation isn't feasible to begin by February, the IEC would be informed accordingly. It was agreed that while there will be a March 2021 consultation, it doesn't need to include the Coincident Service Order NPN Transaction changes.

Aakash Sembey (Simply) asked how detailed the procedure changes should be, and whether it should be a simple proposal. Adrian Honey (TasNetworks) stated that detailed procedures would inform a cost/benefit analysis. Meghan Bibby (AEMO) noted that the OWN Procedures doesn't include business processes – the SO processes do.

Helen Vassos (PLUS ES) proposed her NPN ICF be considered in the consultation. Aakash Sembey (Simply) noted that the IEC would prefer no schema change be made, so they may have to be consulted on separately.

Dino Ou (Endeavour) proposed it be called out in the Issues Paper that Victoria are not subject to these changes as they don't have metering contestability. Robert Mitchell (EQ) stated that QLD is not a hard and fast regarding the Remote De-en but does have hard rules around the requirement to have the DB perform a visual inspection on any type of Re-en, so should be considered in the cost benefits etc. Robert also mentioned that QLD will be revisiting these

rules. Robert Lo Guidice (intelliHUB) replied that whilst QLD's rules are revisited, the rule has not changed.

B2B-WG to confirm preference to consult on all items together rather than running them in parallel.

Actions (due 5 February, IEC papers due 8 February, proposed B2B-WG meeting 15 February. Can be presented via circular):

- Meghan Bibby and Jordan Daly (AEMO) to recirculate prior NotifiedParty documents to B2B-WG for consideration in Issues Paper (ie: Helen's ICF).
- Aakash Sembey (Simply), Mark Riley (AGL), Christophe Bechia (Red) and Paul Greenwood (Vector) to outwork details of track-changed Procedures for the proposal. The SO Procedure, B2B Guide and possibly OWN Procedure will need changes.
- AEMO to propose options for consultation timelines.
- Nandu Datar and Noura Elhawary (AEMO) to set up skeleton Issues Paper for B2B-WG members to fill out.
- B2B-WG to decide whether to propose specific implementation dates for the proposed change in the Issues Paper or whether to leave this open-ended as a question for respondents.
