- · Blaine Miner (AEMO) spoke, and provided additional context, to the Actions Log slides
- Blaine mentioned that a number of today's agenda items are as a result of completing actions
- Re Action 100223 11:
 - Members agreed that the definition of an empty string, for B2B Procedure purposes, should be added to the Technical Specification and referenced where applicable in the Procedures
 - New Action:
 - Amend ICF B006/22 to include the definition of an empty string, for B2B Procedure purposes, in the Technical Specification and referenced where applicable in the Procedures
- Re Action 100223 15
 - B2B WG members, including those that attend the ASWG, agreed that the ASWG's processes and communications needs to be improved and that the ASWG should take more accountability for upstream (applicable business forum support) and downstream requirements (Tech Spec changes)
 - Lenard Bull (AEMO) stated that he will ask to be added to the ASWG in the interim
 - Blaine confirmed that there are internal AEMO discussions occurring regarding how AEMO's line of sight regarding our end-to-end change processes can be improved
- Re Action 100223 19
 - · Aakash Sembey (Origin) volunteered to draft the Boolean values issue ICF
- David Woods (SAPN) and Mark Riley (AGL) spoke to the proposed B2B Guide improvement process approach
 - Helen Vassos (PlusES) questioned if having a separate spreadsheet capturing the proposed changes is the most efficient and effective way of communicating proposed Guide changes
 - Mark mentioned that he is already well advanced in the spreadsheet process and that if we were to follow a conventional change marking process, the whole Guide would look like it was change marked
 - · David stressed that the Guide improvements do not involve any changes in obligations, more about useability
 - In response to a suggestion re a shared SharePoint site, Lenard stated that it is unlikely that AEMO would be able to support a shared SharePoint location but would investigate further
 - New Action:
 - Lenard to confirm if AEMO can support/provide a secure SharePoint site
 - Mark and David committed to circulating the initial cut of the spreadsheet prior to the next monthly meeting
 - New Action:
 - Mark and David to circulate the proposed changes to the B2B Guide spreadsheet prior to next month's' monthly meeting
 - Paul Greenwood (Vector) offered his assistance



NEM RoLR Processes (Part B) Procedure - Customer Details Enhancement





- IEC discussed the B2B WG's recommendation:
 - To seek approval from the IEC regarding the B2B Working Group's recommendation to:
 - · enhance RoLR B2B Customer Details Report provided by failed retailers to the Retailer of Last Resort (RoLR); and
 - correct identified errors in the NEM RoLR Processes (Part B) Procedure.
- In considering the proposed changes, the B2B WG has also recommended that this consultation be performed on an expedited basis.
 - This recommendation is based on the fact that the changes are considered non-material (pre-existing processes and the customer details report is only built at the time of a RoLR occurring), this approach has been confirmed with AEMO legal.
 - If during the consultation a material issue is raised, then the consultation can revert to a standard consult.
- IEC decision:
 - The IEC endorsed the B2B WG's recommendations
- Consultation status:
 - Expedited Draft Report and Determination (Draft Report) published 2 March 2023
 - Submissions close 31 March 2023
 - Final Report and Determination (Final Report) to be published by 28 April 2023

- Blaine Miner (AEMO) spoke, and provided additional context, to the NEM RoLR Processes (Part B) Procedure slide
- Dino Ou (Intellihub) stated that Intellihub had identified some material system impacts associated to the change in obligations regarding Service Order mgt during a RoLR event e.g. Remote De-energisations
 - · Wayne Farrell (Yurika) mentioned that there may be some impacts identified for Yurika as well, additional system logic
- Aakash Sembey (Origin), Mark Riley (AGL) and Jo Sullivan (EA) questioned why these processes weren't already in place, as 7 RoLR events happened
 last year
 - Dino mentioned that:
 - · Fortunately last years' events were low in volume for Intellihub and that manual processes were possible
 - · Due to the proposed change in obligations, automated processes would be preferrable to ensure compliance
- Dino mentioned that Intellihub are not seeking to change the consultation from Expedited to Standard but that a change in effective date associated to the change in service order obligations would be requested e.g. 6-9mth delay
- Blaine mentioned that Intellihub, and other stakeholders, can provide submissions as part of the current consultation process
 - The B2B WG would consider submissions initially and then provide recommendations to the IEC
 - The IEC would then consider the submissions and the B2B WG's recommendations and then form their final positions, e.g.:
 - Proceed with its Draft positions
 - Separate the changes and apply different effective dates e.g. 15 May 2023 for the change is the customer details report, x date in the future for the alignment of the service order obligations
 - Reconsider the IEC's initial positions more broadly, including consultation approach
- Timing between when a RoLR event is declared and when the effected NMIs' FRMP gets updated is the key issue i.e. when the FRMP is updated, previously requested service orders are not actioned
- Paul Greenwood (Vector) mentioned that the IEC may not change its position due to Participant Readiness
- Aakash mentioned that Retailers have had to deal with compliance obligations as a result of RoLR events up until now, without required information being easily accessible from failed retailers

- Blaine Miner (AEMO) spoke, and provided additional context, to the NEM 2025 Initial Assessment slide and the associated draft spreadsheet
- Blaine confirmed that as per the most recent PCF meeting, the Roadmap is currently under review and that an updated version will likely be published in April/May
- Adrian Honey (TasNetworks) recommended that a 'Comments/Assumptions' column be added to the spreadsheet
 - Sean Jennings (Red/Lumo) supported Adrian's recommendation
- Mark Riley (AGL) and Adrian Honey (TasNetworks) suggested that most of the initiatives would likely not have a B2B impact
- Blaine suggested that the B2B working should periodically review their previous assessments to ensure they are still appropriate, in case new information has come to light

- Blaine Miner (AEMO) spoke, and provided additional context, to the B2M Update slide
- Following a comment from Blaine, Mark Riley (AGL) agreed that the Inventory File/Table ICF and the emerging NMI Status enumerations ICF may be best placed in the B2B WG in the first instance, as opposed to the ERCF
- Mark Riley (AGL) provided some high level context to the WG re the issue of a potential misalignment between the physical status of a NMI and the market/MSATS status of a NMI during an extreme weather event
 - Helen Vassos (PlusES) cautioned members re a potential NMI Status enumerations solution, as there is currently significant downstream logic associated to this field. Any proposed change(s) to this field would likely result in significant system and process implications for Participants.
 - Members discussed current Retailer and DB processes around this issue
 - New Action:
 - Mark Riley (AGL) to update B005/22 to reflect the latest thinking re the Inventory File/Table proposal
 - Mark Riley (AGL) to present additional detail next month re the issues associated to the potential disconnect between the physical status of a NMI and the market/MSATS status of a NMI during an extreme weather event
- Consumer Data Right (CDR)
 - Blaine noted that AEMO is currently considering a request from EA, Origin and AGL re delaying their LCCD maintenance obligations to 1 Nov 2023
 - Blaine mentioned that if AEMO supported this request, a further formal consultation will be required
 - New Action: AEMO to reconfirm what the LCCD is meant to represent i.e. the day of or day after consideration


