1. Welcome and attendance / apologies - Roger Shaw, AEMO

Roger Shaw (AEMO) welcomed all to the meeting.

2. AEMO Competition Law Protocol - Roger Shaw, AEMO

The GWCF noted AEMO's Competition Law Protocol and its requirements on both AEMO and participants.

3. Confirm agenda and previous meeting minutes and actions - Roger Shaw, AEMO

The GWCF confirmed the agenda.

The GWCF confirmed the previous meeting minutes as accurate.

The action items table appended to these minutes has been updated.

4. Certificate Replacement Program - Travis Kane, AEMO

Travis Kane (AEMO) spoke to the provided slides.

5. AEMO Fee Consultation - Andrea Marinelli, AEMO

Andrea Marinelli (AEMO) noted that AEMO is currently consulting on the fee structures for gas participants. This consultation can be found here¹. Andrea noted that participants were welcome to arrange a time if they wished to discuss the consultation with AEMO, in which instance could contact kevin.ly@aemo.com.au. Submissions to the consultation are due 19 October 2020.

6. AER standing agenda item - Max Hooper, AER

Max Hooper (AER) noted two compliance items regarding the Day-Ahead Auction (DAA):

- The AER would be sending a notice to shippers requesting that they provide reasons for material renominations by the end of September. The AER will be sending these notices as entitled under NGR rule 666(4).
- The AER has noted a number of late auction quantity limits (AQLs) on the DAA. Max reiterated that if there are problems on the day that require a late AQL to be submitted, then that participant should contact the AER and AEMO to notify them that that is the case.

7. AEMC standing agenda item - Daniela Moraes, AEMC

Daniela Moraes (AEMC) noted that the AEMC expected to begin consultation on the DWGM Maintenance Planning Rule Change by late October, with the intent to publish a final rule by the end of 2020. The rule change proposal can be found at https://www.aemc.gov.au/rule-changes/dwgm-maintenance-planning.

8. AEMO Gas Market Monitoring Markets update - Saul Milner and Darryl White, AEMO

Saul Milner (AEMO) spoke to some slides examining the cause of \$10 prices in the Brisbane STTM. Darryl White (AEMO) spoke to some slides providing an update on winter activity in east-coast gas markets.

9. AEMO Gas Market Monitoring general update - Robbie Flood, AEMO

Robbie Flood (AEMO) spoke to the slides provided.

Andrew Robertson (APGA) noted that APA Group had launched a Pipeline Information Web Portal to help consolidate information about gas pipelines (in line with action item 26.8.1); this can be found here: https://www.apga.org.au/pipeline-information-users.

10. DWGM Enhancements Working Group verbal update - Roger Shaw, AEMO

Roger spoke to the provided slides regarding the DWGM Enhancements Working Group.

A number of GWCF participants noted a desire to review Curtailment Tables. Roger Shaw (AEMO) noted that AEMO had already intended a review in order to remove Table 0 and that it would not be efficient to conduct another review in advance thereof. Roger noted that this

review would be run out of the <u>Gas Emergency Management Consultative Forum (GEMCF)</u>². Melissa Perrow (Brickworks) asked that large energy users therefore be included in the GEMCF in order that they may be consulted on these changes. Luke Garland (AEMO) noted that he would liaise with Energy Safe Victoria (ESV) to discuss whether large energy users could be included in the GEMCF (Action item 27.10.1).

11. DWGM Communications Procedure update – Luke Stevens (AEMO)
