#### 1. Welcome and attendance / apologies - Roger Shaw, AEMO

Roger Shaw (AEMO) welcomed all to the meeting.

Roger noted Arjun Pathy (AEMO) and Melissa Perrow (Brickworks) as apologies.

#### 2. AEMO Competition Law Protocol – Roger Shaw, AEMO

The GWCF noted AEMO's Competition Law Protocol and its requirements on both AEMO and participants.

#### 3. Confirm agenda and previous meeting minutes and actions - Roger Shaw, AEMO

The GWCF confirmed the agenda.

The GWCF confirmed the previous meeting minutes as accurate.

The action items table appended to these minutes has been updated.

# 4. AER Update – Max Hooper, AER

Max Hooper (AER) spoke to the slides provided.

Max Hooper (AER) specifically noted gas shippers' responsibility for maintaining records of monitoring material renominations in the Day-Ahead Auction. The AER has issued penalties in relation to insufficient record keeping. The AER will review its Record Keeping Guideline in 2021.

Max Hooper (AER) further noted that many participants provided late auction quantity limit (AQL) submissions from facility operators, and that if a late submission was to be provided, facility operators should give AEMO and the AER notice.



## 5. AEMC Update - Daniela Moraes, AEMC

The AEMC noted that it would be reviewing the Gas Supply Guarantee in 2021.

Scott Young (APA Group) noted APA Group's rule change submission regarding the DWGM Maintenance Planning Rule Change. Luke Garland (AEMO) noted that AEMO's and the AEMC's respective legal teams did not believe that APA Group's legal interpretation of the rule change were correct, but that the AEMC and AEMO would provide further clarity via other means (e.g. via AEMO's procedures).

#### 11. Gas Quality and Metering Rule Change Update – Luke Garland (AEMO)

Luke Garland (AEMO) spoke to the paper. Luke noted that AEMO would provide an update on hydrogen to present to the GWCF in March 2020.

#### 12. Other Business

#### **APA Group Community Consultation Group for VTS Access Arrangement consultation**

Scott Young (APA Group) thanked all participants who have already provided input to the VTS Access Arrangement consultation and invited any participants with interest to provide input.

#### IT Facility for Manual AQL Submission

Ee Siew Ong (Lochard Energy) spoke to the GMI provided. Ee Siew noted that Lochard's proposal is to allow manual submission of AQLs as an alternative to API submissions, in case there are IT difficulties that prevent API-based submission. Roger Shaw (AEMO) noted that proponents would need to provide benefits to justify AEMO's making the change. Jamie Coombs (SEA Gas) noted that APIs are very efficient when they work, but when there are difficulties, the staff on-hand are likely able to provide a CSV file but may not have the technical capability for resolving the API difficulties. Roger Shaw (AEMO) noted an action for all facility operators to provide their expected benefits and risks from the proposal outlined in Lochard Energy's GMI (Action item 29.12.1).
