1. Welcome and attendance / apologies - Hugh Ridgway, AEMO

Hugh Ridgway (AEMO) welcomed all to the meeting.

2. AEMO Competition Law Protocol – Hugh Ridgway, AEMO

The GWCF noted AEMO's Competition Law Protocol and its requirements on both AEMO and participants.

3. Confirm agenda and previous meeting minutes and actions – Hugh Ridgway, AEMO

The GWCF confirmed the agenda.

The GWCF confirmed the previous meeting minutes as accurate.

The action items table appended to these minutes has been updated.

4. AER Update - Jeremy Llewellyn, AER

Jeremy Llewellyn (AER) provided the AER update. Jeremy thanked gas market participants for their engagement with the AER throughout the year. Jeremy further noted that the AER would continue to communicate with participants regarding auction quantity limits and demand forecasting in the STTM in 2022.

5. AEMC Update - Meredith Mayes, AEMC

James Tyrell (AEMC) provided the AEMC update. James noted that the AEMC's <u>Review of the Gas Supply Guarantee</u> had been finalised on 4 November 2021. James further noted that the consultation periods for the <u>Review into extending the regulatory frameworks to hydrogen and renewable gases</u> and the <u>DWGM distribution connected facilities</u> rule change had concluded on 2 December 2021 and that stakeholder workshops would be upcoming on both initiatives.

6. Gas Market Monitoring Markets Update - Darryl White (AEMO)

Darryl White (AEMO) provided the Spring Update and spoke to the provided slides.

7. Gas Market Monitoring General Update – Robbie Flood (AEMO)

Robbie Flood (AEMO) noted that the consultation had concluded on <u>changes to the Capacity Trading and Auction Procedure (CTAP)</u>. No feedback had been received, so AEMO proceeded with the changes. Robbie noted that the CTAP consultation had raised the need for a subsequent consultation on the transportation service point register, the consultation for which will continue into January.

Robbie Flood (AEMO) noted that AEMO was waiting for the passage of changes to Gas Transparency Measures to be passed by the SA Parliament before AEMO progressed the changes. AEMO is issuing some changes into preproduction and Robbie asked that any participant using APIs to download reports to test those changes in preproduction. Robbie further noted that FTP would be decommissioned for bulletin board submissions in 2022.

8. DWGM Enhancements Capacity Certificate Zone Consultation – Yvonne Tan (AEMO)

Yvonne Tan (AEMO) spoke to the slides.

Ee Siew Ong (Lochard Energy) asked what considerations AEMO would take into account with how it would allocate connection points to zones. Yvonne responded that AEMO did not



have a preference regarding how connection points would be allocated to zones and therefore that AEMO would primarily consider industry feedback.

Yvonne Tan (AEMO) noted that feedback to the PPC would close on 22 December 2021 and that the IIR would be published in mid-January 2022.

9. OTSCP Nominations – Jordan Daly (AEMO)

Jordan Daly (AEMO) noted that AEMO has opened nominations on the OTS Code Panel. Jordan noted that nominations were needed for the following positions:

- Transportation Service Provider Member.
- Transportation Facility User (General) Member.
- Transportation Facility User (Large Users) Member.

10. Other Business

Yvonne Tan (AEMO) noted that market participants should review their accreditation in INT118A and underpinning logical CTMs in INT055 to ensure they had set up new and updated accreditations for the 2022 calendar year, as per the market notice sent out on 24 November 2021. Yvonne further noted that STTM participants should review their registered facility services in INT705 and trading rights in INT706 for the 2022 calendar year, as per a different market notice sent out on 24 November 2021.

11. Meeting close - Hugh Ridgway, AEMO
