## POWER OF CHOICE PROCEDURE CHANGES (PACKAGE 1)

**Date of Notice: 22 April 2016**

This notice informs all Registered Participants and interested parties (**Consulted Persons**) that AEMO is conducting a consultation on AEMO Procedures amended in relation to the Competition in Metering, Embedded Networks and Meter Replacement Processes rule changes (**Amending Rules**).

This consultation is being conducted under rules 11.86.6, 11.87.2 and 11.88.2 of the National Electricity Rules (**NER**), in accordance with the Rules consultation requirements detailed in rule 8.9 of the NER.
