

Unit Category Data – July to September (Q3) 2017 - Revised

Clauses 4.5, 5.3 and 11.1 of the Auction Rules require AEMO to advise Auction Participants of the following information concerning the auction of the inter-regional settlement residue units for a given quarter:

- Proportions.
- Maximum number of units.
- The dates on which auctions will be held.
- Auction expense fees.

For 2017 Quarter 3 this information has previously been published by AEMO. In accordance with Clause 11.3 of the Auction Rules, AEMO has subsequently reconciled the auction expense fees recovered for 2016/17 against costs incurred and determined that there was an over recovery. AEMO has therefore adjusted the auction expense fees for 2017/18 to return the difference found in 2016/17. The original and revised auction expense fees for 2017 Quarter 3 are presented below.
