AMDQ CREDIT CERTIFICATE (AMDQ CC) AUCTION COMPLETION NOTICE 2018

In accordance with the National Gas Rules (NGR) rule 329G, the Australian Energy Market Operator (AEMO) has completed the auction of AMDQ credit certificates (AMDQ CC) for the Victorian Declared Wholesale Gas Market (DWGM).

Market Participants submitted bids for an allocation using the Bid form published on AEMO's website. There were seven submissions from Market Participants.

Provisional allocations have been made and the letters have been sent to the successful bidders advising their AMDQ CC allocation. The effective period of the AMDQ CC allocation will be from effective start date (subjected to criteria in the Wholesale Market AMDQ Procedures being met) to 31 December 2022 (inclusive).

The provisional allocations are as follows:

The proceeds from the AMDQ CC Auction \$500,500.00 will be used to offset AEMO's costs of operating the DWGM.
