## 1. Introduction

This release of the aseXML schema defines the new namespace as “urn:aseXML:r9” and is based on the <http://www.w3.org/2001/XMLSchema> specification version 1.0. The schema is based on the aseXML schema r8 with target namespace of “urn:aseXML:r8” that was migrated from the r7 patch 1 schema.

The schema is changed as result of the MSATS 2 functional requirements and required fixes of MSATS 1.1, the Gas FRC transaction definitions and convergence requirements for the aseXML schema. This document defines the list of the files included in various releases of the aseXML schema to date as well as the changes in each file.

This schema allows for interoperability. After transitional period, the interoperability component of the schema will be removed.

The main changes are detailed below.

- It incorporates the changes from the meter register workshop, resulting in the specification of MSATS V2.
- It corrects two minor defects in MSATS V1.1 related to standing data – the use of the term EstablishmentInstructions instead of EstimationInstructions, and the definition of AverageDailyLoad on DataStreams as a decimal instead of an integer.
- The definitions of DLF Values and Meter Test Result Accuracy are further restricted to limit these fields to more realistic values.
- The Transaction Type Code has been added in the relevant rows for C1 reports clarification
- Two transactions: CATSNotification and MeterDataNotification were altered as result of their use in Gas and B2B. Alteration does not affect the MSATS transactions, as the added elements will not be used.

Due to the extensive nature of changes to the schema for B2B and Gas FRC transactions, the summary of changes is not provided for this release

- A new section 4 was added to define the changes resulting from the parser validation tests.
- The associated zip file provides, in addition to the r9 schema, a set of sample XML files that uses the relative path for schemaLocation as well as published URL and are located in the respective sub-folders

#### 3.1. Acknowledgments


- The definition of ReceiptIdentifier based on UniqueIdentifier was reinstated by means of using the r6 version of the file.





### 3.5. CATSTableReplication

- Modified data stream row formats to allow for average daily load being changed from a decimal to an integer.
- Added new row formats for meter register configuration (master data and change requests)
- Added optional version attribute to modified table formats; the attribute will become mandatory after the transitional period.
- Address in the ElectricityNMIMasterGroup uses AustralianPartialAddress complex type
- Role in the CATSObjectionRow become optional
- DistributionLossFactorCodeRow extended with the version attribute due to change in the DistributionLossFactorValue type
- Party in ElectricityNMIRoleGroup is declared nullable.
- Optional element TransactionTypeCode added to CATSChangeResponseRow, CATSObjectionRow and CATSObjectionResponseRow
- Added optional version attributes to the changed rows; they will become mandatory after the transitional period.
- Spelling error corrected and CATSChangeInitiationRuleRow changed in CATSChangeInitiationRuleRow


### 3.9. CustomerTransfer

- The r9 release modifies the "Participant" element of the type CATSChangeRequestNotificationData to be nillable.




This is required because the VENCorp does not include the details of New-FRO in CATSNotification.

- An optional element ObjectionDate has been added to the CATSObjectionNotificationData.
- The version attribute of the CATSNotification has been updated to r9.
- A new complexType CATSChangeAlert has been introduced for the corresponding transaction.



- Optional element ObjectionDate added to the CATSObjectionNotificationData. Consequently, version attribute for the CATSNotification transaction became r9. The content of MSATS CATSNotifications may remain the same because the added element is optional.



  - NetworkTariffCode will also be removed after transitional period from the Meter record as it is already provided in the Register record.







- GasMeterPosition – added missing elements from the read. The excel spreadsheet row height limitations doesn’t allow to print all the elements in the list.




### 3.17. **MeterDataManagement**
