ENERGY ADEQUACY ASSESSMENT PROJECTION (EAAP): GUIDELINE AND SPOT MARKET OPERATIONS TIMETABLE (TIMETABLE) AMENDMENTS

Date of Notice: 2 June 2016

This notice informs all Registered Participants and interested parties (**Consulted Persons**) that AEMO is conducting a consultation to amend *EAAP* Guidelines , Reliability Standard Implementation Guidelines (RSIG) and Timetable.

This consultation is being conducted under clauses 3.7C(k), 3.9.3D and 3.4.3(b) of the National Electricity Rules (**NER**), in accordance with the Rules consultation requirements detailed in rule 8.9 of the NER. NER clause 11.78.1 requires the revised guidelines to be published by 31 October 2016.

Matter under Consultation

The matter for consultation is proposed revisions to *EAAP* guidelines , RSIG and Timetable.

Invitation to Make Submissions

AEMO invites written submissions on the matter under consultation, including any other proposed approaches you consider may better meet the objectives of this consultation and the National Electricity Objective.

Please identify any parts of your submission that you wish to remain confidential, and provide the reasons why you wish that that information be treated as confidential. AEMO reserves the right to publish material it does not consider it to be confidential, but will consult with you before doing so.

Please note that material identified as confidential may be given less weight in the decision-making process than material that is published.

Meetings

In your submission, you may request a meeting with AEMO to discuss the matter under consultation. If you request a meeting, you must advise why you consider a meeting is necessary or desirable.

If appropriate, meetings may be held jointly with other Consulted Persons. Subject to confidentiality restrictions, AEMO will generally make details of matters discussed at a meeting available to other Consulted Persons, and may publish them.
