Notes (red text highlights action items)

1. Previous actions summary

- AEMO thanked POC-RWG members for their feedback on the Market Readiness Strategy (v0.2), Industry Readiness Reporting Plan (v0.1) and scoping of the Participant Information Sessions, following the 5 August 2016 meeting. AEMO had incorporated the feedback into today's papers.
- AEMO invited the AER to join the POC-RWG, in response to a POC-RWG member request. The AER's preference is to attend POC-RWG meetings on a case-by-case basis and provide information on specific issues and matters of interest to POC-RWG members.
- The POC webpages on <u>www.aemo.com.au</u> are being updated over the next month for all of the POC work streams, including Market Readiness. The webpages will include terms of reference for working groups, names of working group members, and meeting papers and notes.
- POC-RWG members were invited to provide feedback to AEMO on the types of POC related issues they would like to discuss with AEMO's Consumer Forum, so as to facilitate discussion. The next meeting of the Consumer Forum is scheduled for November 2016.
- AEMO reminded persons participating in today's POC-RWG meeting to register with AEMO if they were yet to do so. In future, AEMO will email all POC-RWG marked correspondence to the POC-RWG email distribution list only. This will result in better targeted communications to participants and interested stakeholders as several POC working groups and forums now exist.

2. Market Readiness Strategy

 AEMO presented v0.3 of the draft Market Readiness Strategy, incorporating feedback provided by POC-RWG members following the previous meeting. There were no further comments from the POC-RWG on the Market Readiness Strategy. AEMO will finalise the Market Readiness Strategy as v1.0 after the meeting, and distribute it to POC-RWG members for their information.

3. Industry Readiness Reporting Plan

- AEMO presented v0.2 of the Industry Readiness Reporting Plan (including reporting templates), incorporating feedback provided by POC-RWG members following the previous meeting. Changes from v0.1 included: reporting at a participant role level; high-level summary reporting by jurisdiction; reporting on the number of open risks and issues; and including a specific criteria on B2B e-hub readiness for industry testing.
- At the meeting, several distribution network service provider members of the POC-RWG noted a strong preference for reporting at a whole-of-business level, rather than at a participant role level.
- Subject to any further comments received from POC-RWG members by 22 September 2016, AEMO will update and finalise the Industry Readiness Reporting Plan (including reporting templates) as v1.0, and distribute it to POC-RWG members in preparation for the start of monthly readiness reporting from mid-November 2016.

4. Participant Information Sessions Scoping

- AEMO summarised the feedback it had received from POC-RWG members on the scope of the six Participant Information Sessions planned for 2016-17.¹ This included being clear on the target audience, a preference for face-to-face delivery, use of PowerPoint slides with notes for easier incorporation of the content into participants' own training programs, and walking through the Procedures and key obligations.
- AEMO overviewed the approach it is taking to developing the content for Participant Information Session #1 – Overview of POC Key Obligations – which is scheduled for mid-October 2016 and targets general expertise staff. An overview of participants' key regulatory obligations under the Rules and Procedures, with a specific focus on the Procedures, will be provided in Session #1 for the four POC related rule changes being implemented by AEMO and industry.
- AEMO will utilise the POC-RWG email distribution list to distribute invitations to attend the Participant Information Sessions. In turn, POC-RWG members will be requested to coordinate attendance on behalf of their organisation.
- AEMO will confirm the mid-October 2016 date for Participant Information Session #1 when it issues the attendance invitation to the POC-RWG later this month.
