

## Unit Category Data – April to June (Q2) 2015 - Revised

Clauses 4.6, 5.3 and 11 of the Auction Rules require AEMO to advise Auction Participants of the following information concerning the auction of the inter-regional settlement residue units for a given quarter:

- Proportions.
- Maximum number of units.
- The dates on which auctions will be held.
- Auction expense fees.

For 2015 Quarter 2 this information has previously been published by AEMO. In accordance with Clause 11.3 of the Auction Rules, AEMO has subsequently reconciled the auction expense fees recovered for 2013/14 against costs incurred and determined that there was an over recovery. AEMO has therefore adjusted the auction expense fees for 2014/15 to return the difference in 2013/14. The original and revised auction expense fees for 2015 Quarter 2 are presented below.
