

Declaration of NDL Association for a DSP

Purpose

In accordance with clause 2.29.5B of the Market Rules, a Market Customer with a Demand Side Programme (DSP) may apply to the AEMO to associate a Non-Dispatchable Load (NDL) with a DSP in the Western Australian Wholesale Electricity Market (WEM).

This declaration may be completed by a Market Customer in order to demonstrate to the AEMO that an associated Load has agreed to provide curtailment on request, in accordance with the requirements of clause 2.29.5B(a) of the Market Rules, where the Market Customer fulfils **either** Criteria A or B below.

This declaration is **not required** if the Market Customer intends to submit a copy of the original demand response contract with its customer, provided the contract meets the requirements of clause 2.29.5B of the Market Rules. This declaration, or the original demand response contract, may be submitted in the **DSP NDL Association Form** in WEMS MPI. If you intentionally make a false statement in this declaration you may subject to a compliance action from the AEMO and may attract a Capacity Credit refund.

This declaration should not be altered without the prior consent of the AEMO.

Market Customer Declaration
