## 1. Background

#### 1.1 Purpose

WEM Section 9.16 requires AEMO to publish information with respect to the settlement cycle timeline for amounts payable under the WEM Rules for all Trading Days within a Financial Year. AEMO must publish the settlement cycle timeline at least one calendar month before the commencement of the Financial Year [WEM Rule 9.16.2]. AEMO must also publish information with respect to each Adjustment Process to be undertaken during the Financial Year [WEM Rule 9.16.4].

With the current market scheduled to end and the new WEM Commencement on 1 October 2023, this document provides information with respect to the settlement cycle timeline for the remainder of the current market, beginning on July 1 2022, the commencement of the 2022-23 Financial Year, and ending in September 2024, in the 2024-25 Financial Year. This document also includes the Individual Reserve Capacity Requirements timeline for the same period.

This document provides the following information:

- the STEM settlement cycle timeline [WEM Rule 9.16.1];
- the STEM settlement adjustment timeline [WEM Rule 9.16.4];
- the Non-STEM settlement cycle timeline [WEM Rules 9.16.2 and 9.19.7];
- the Non-STEM settlement adjustment timeline [WEM Rule 9.16.4];
- the Meter Data Submission timeline [WEM Rule 9.16.2(a)];
- the Individual Reserve Capacity Requirements timeline [WEM Rules 4.1.23, 4.1.23C, 4.1.24 and 4.28.8C]; and
- the Capacity Credit Allocation submission timeline [WEM Rule 9.16.2(b)].

#### 1.2 STEM Settlement Cycle Timeline

WEM Rule 9.16.1 specifies the following STEM settlement cycle timeline:

- STEM Settlement Statement (for each of the Trading Days in the Trading Week) and Invoice for the STEM. Settlement Statements the first Business Day commencing after the end of the Trading Week.
- **STEM Settlement Date** (the date upon which transactions covered by a STEM Settlement Statement are settled) the second Business Day after the Invoice for a STEM Settlement Statement is issued.
- **STEM Settlement Disagreement Deadline** 5pm on the twentieth Business Day after the Invoice for a STEM Settlement Statement is issued. A Market Participant has until this time to lodge a Notice of Disagreement with AEMO pertaining to any amount included in the relevant STEM Settlement Statement.

The STEM settlement cycle timeline is set out in A1.1 STEM Settlement Timeline.

#### 1.3 STEM Adjustment Timeline

Adjustments to STEM Settlement cycles will be notified as required. It is not anticipated that a STEM Settlement Adjustment will occur under the current WEM Rules.

#### 1.4 Non-STEM Settlement Cycle Timeline

WEM Rules 9.16.2(c)-(f) specify the following Non-STEM settlement cycle timeline:

- Non-STEM Settlement Statement Date (the Business Day by which AEMO must issue Non-STEM Settlement Statements for a Trading Month) – not less than three Business Days and not more than five Business Days after Meter Data Submissions are provided to AEMO.
- **Invoicing Date** (the Business Day by which AEMO must issue Invoices for Non-STEM Settlement Statements for a Trading Month) the sixth Business Day of the second month following the month in which the Trading Month being settled commenced.
- Non-STEM Settlement Date (the Business Day on which the transactions covered by a Non-STEM Settlement Statement are settled) the eighth Business Day of the second month following the month in which the Trading Month being settled commenced.
- Non-STEM Settlement Disagreement Deadline 5:00pm on the first Business Day of the eleventh month following the month in which the Trading Month being settled commenced. A Rule Participant has until this time to lodge a Notice of Disagreement with AEMO in relation to any amount included in the Non-STEM Settlement Statement.

The Non-STEM settlement cycle timeline is set out in A1.2 Non-STEM Settlement Timeline with the Notice of Disagreement timeline in A1.4 Non-STEM Settlement Notice of Disagreement Timeline .

#### 1.5 Non-STEM Adjustment Timeline

AEMO undertakes a process for adjusting settlements ("Adjustment Process") at least once every three months. The purpose of the process is to review the relevant Settlement Statements to facilitate corrections resulting from Notices of Disagreement, the resolution of Disputes and revised metering data provided by Metering Data Agents. Adjustments may only be made to Relevant Settlement Statements. Adjustments may not be made to Settlement Statements outside of an Adjustment Process.

WEM Rule 9.16.4 specifies the following Non-STEM settlement adjustment timeline:

- Non-STEM Settlement Adjustment Commencement Date the commencement date for the settlement adjustment process.
- Non-STEM Settlement Adjustment Statement Date (the Business Day by which Non-STEM Settlement Adjustment Statements for a Trading Month must be issued) not less than 20 Business Days after the Commencement Date.
- **Invoicing Date** (the Business Day by which AEMO must issue Invoices for Non-STEM Settlement Statements for a Trading Month) not less than two Business Days after the Statement Date.
- **Non-STEM Settlement Date** (the Business Day on which the transactions covered by a Non-STEM Settlement Statement are settled) not less than two Business Days after the Invoicing Date.
- Non-STEM Settlement Disagreement Deadline 5:00pm on the first Business Day of the eleventh month following the month in which the Trading Month being settled commenced. A Rule Participant has until this time to lodge a Notice of Disagreement with AEMO in relation to any amount included in the Non-STEM Settlement Statement.

The Non-STEM settlement adjustment timeline is set out in A1.3 Non-STEM Settlement Adjustment Timeline with the Notice of Disagreement timeline in A1.4 Non-STEM Settlement Notice of Disagreement Timeline ..

#### 1.6 Meter Data Submission Timeline

WEM Rule 9.16.2(a) states that the Interval Meter Deadline (the date by which Meter Data Submissions for a Trading Month must be provided to AEMO) is the first Business Day of the second month following the month in which the Trading Month commenced.

The Meter Data Submission timeline is set out in A1.2 Non-STEM Settlement Timeline and A1.5 IRCR and Capacity Credit Allocation Timeline.

#### 1.7 IRCR and Capacity Credit Allocation Submission Timeline

#### 1.7.1 IRCR Data Provision

WEM Rule 4.1.23 and 4.28.8C specifies the time by which Market Customers must provide AEMO:

- the identity of all interval meters associated with that Market Customer that the Market Customer wants AEMO to treat as Non-Temperature Dependent Loads (NTDLs);
- details of any Demand Side Management (DSM) measures that the Market Customer has implemented since the previous Hot Season, including the expected MW reduction in peak consumption resulting from those measures; and
- nominations of capacity requirements for Intermittent Loads (IL).

For the purpose of Non-Temperature Dependent Load assessment under Appendix 5A of the WEM Rules a Market Customer may provide evidence that the source of consumption was operating at below capacity due to maintenance or a Saturday, Sunday or a public holiday throughout Western Australia. If a Market Customer wishes to provide this information, it must be provided by the same deadline for providing the identity of the interval meters.

The deadlines for the provision of information are as follows:

- For the first month of a Reserve Capacity Cycle 5:00PM on the last business Day on or before 20 August of Year 3 of that Cycle.
- For other months within a Reserve Capacity Cycle:
  - For NTDL and DSM measures submissions 5:00PM 15 Business Days prior to the Indicative Individual Reserve Capacity Requirements publication deadline for the Trading Month [WEM Rule 4.28.8C].
  - For new IL submissions 5:00PM 5 Business Days prior to the Indicative Individual Reserve Capacity Requirements publication deadline for the Trading Month [WEM Rule 4.28.8A].

#### 1.7.2 IRCR Publication

WEM Rule 4.1.23C specifies the time by which AEMO must publish the Indicative Individual Reserve Capacity Requirements as by 5:00PM 10 Business Days prior to the start of the relevant Trading Month.

WEM Rule 4.1.24 specifies the time by which AEMO must publish the Individual Reserve Capacity Requirements as by 5:00PM 5 Business Days prior to the Interval Meter Deadline of the relevant Trading Month.

WEM Rule 4.28.11A specifies the recalculation and publication of Individual Reserve Capacity Requirements performed during the Adjustment Process for a Trading Month. These recalculated values are published on the same day as the relevant Trading Month's Settlement Statement.

#### 1.7.3 Capacity Credit Allocation and Acceptance

WEM Rule 9.16.2(b) specifies the following requirements with respect to the Capacity Credit Allocation Submission and Acceptance timeline:

- **Earliest Submission and Acceptance Date** (and time) at which Capacity Credit Allocation Submissions and Capacity Credit Allocation Acceptances for a Trading Month can be submitted not less than 10 Business Days prior to the start of the relevant Trading Month.
- Latest Submission and Acceptance Date (and time) at which Capacity Credit Allocation Submissions and Capacity Credit Allocation Acceptances for a Trading Month can be submitted the Interval Meter Deadline of the relevant Trading Month.

The Individual Reserve Capacity Requirement timeline and the Capacity Credit Allocation timeline is set out in A1.5 IRCR and Capacity Credit Allocation Timeline.

#### 1.8 Definitions and Conventions

All references to times are Australian Western Standard Time (AWST).

#### Table 1: Defined Terms

Term	Definition
Business Day	A day that is not a Saturday, Sunday or a public holiday throughout Western Australia. For the purpose of WEM Rule clauses 9.16.1(b), 9.16.2(e) and 9.16.4(d), a Business Day is a day that is not a Saturday, Sunday, or a public holiday (including a bank holiday) throughout Western Australia and/or Sydney (New South Wales).
	*The public holiday date for the Queen's Birthday in Western Australia in 2024 has not yet been proclaimed. The proclaimed date may disrupt settlement dates in this document.
Trading Day	A period of 24 hours commencing at 8.00am on any day after Energy Market Commencement, except where AEMO declares that part of a Trading Day is to be treated as a full Trading Day under clause 9.1.1 of the WEM Rules, in which case that part is a Trading Day.
Trading Month	A period from the beginning of a Trading Day commencing on the first day of a calendar month to the end of the Trading Day that finishes on the first day of the following calendar month.
Trading Week	A period from the beginning of a Trading Day, commencing on a Thursday, to the end of the Trading Day that finishes on the following Thursday.
