## DETAILS

### Change

Recently, AEMO's Gas FRC Hub configuration changed to support the FRC Hub sending outbound transactions to gas participants' gateways as a DNS Name.

As a result, when AEMO sets up destination addresses for gas participants' gateways AEMO can add a URL in the host field, see Figure 1 below.

### Unchanged

AEMO continues to support the existing functionality of internet or MarketNet IP addresses for participants' gateways.

Participants continue to handle the obligation to inform the relevant gas market of any performance degradation, gateway outage, and so on.

## Using the DNS name

Participants using this feature can change their internet DNS to manage their gateways' Disaster Recovery (DR), switching between production, DR sites, and standby gateways without having to involve AEMO.

To use this feature, gas market participants can send a signed FRC Hub registration form to AEMO's Support Hub requesting testing in the pre-production environment. When working and tested the Support Hub can promote it to production.
