# 1 Introduction

## 1.1 Purpose

This guideline has been produced to map the Heating Value Zone (HVZ) to a Custody Transfer Point (CTP) in the Queensland Gas Retail Market to provide a guidance to the Queensland Retail Market.

This procedure provides up to date information on the mapping of heating value zone to custody transfer points that are connected to their distribution region as stated in the Retail Procedures Queensland 6.2.2 Obligation of Distributors.

AEMO will contact the distribution companies in Queensland on a regular basis and request an update. An updated version of the HVZ to CTP mapping will be published by AEMO.

This guideline is aimed at participants in the Queensland Gas Retail Market.
