1. INTRODUCTION

These are the release notes for GBB (WA) 1.9 (Build 329). This release addresses important issues described in sections below.

STAKEHOLDER REQUESTS

Publication Checks (GISP-999)

In the event thatGas Market Participants do not meet submission deadlines as specified in the GSI Rules, the GBB (WA) has introduced a feature that allows AEMO to republish reports after the autopublication schedule. This enables AEMO to update published reports with the latest available data received from late submissions.

At the request of AEMO's market auditors, GBB 1.9 introduces an additional validation that prevents the publication of reports prior to the auto-publication times.

GBB Notice Board (GISP-996)

At the request of a Market Participant, the GBB Notice Board has been renamed as **Industry Information** while also being moved to be under the Participant tab in the GBB. To support this change and more broadly reflect that the page is for information for all suppliers and consumers of natural gas rather than restricting it to gas market participants, the description has been updated as follows:

This Industry Information is published to enable suppliers and consumers of natural gas to share details about opportunities for the sale or purchase of natural gas, or natural gas services. The information on this page has been provided by stakeholders in the Western Australian gas industry. AEMO does not warrant the accuracy of the information nor accept any liability for any actions taken in reliance on this information. AEMO reserves the right to remove any information published on this section of the GBB (WA) by a Gas Market Participant, or by AEMO on behalf of a non-Gas Market Participant, at any time and for any reason.
