Whilst there would be benefits from the refinements (consolidate and retire) flagged in Option 1 we feel the additional consolidation under the 4 core streams proposed in Option 2 would lead to greater focus of the working groups/forums and lead to more effective outcomes. We feel the extra level proposed in Option 3 (CEO round table) would also help to achieve a higher level strategic objective

  - Yes
