

NOTICE OF WHOLESALE DEMAND RESPONSE AMENDMENTS TO CONSOLIDATING PROCEDURES

National Electricity Rules – Rule 7.16.7

Date of Notice: Thursday 5 August 2021

This Notice informs all Registered Participants, Metering Providers, Metering Data Providers, Embedded Network Managers, Ministers and the AER (Persons) that AEMO is conducting a process (Consolidation Process) in respect of the proposal (Consolidation Proposal) to consolidate, effective from 24 October 2021, the versions of the Retail Electricity Market Procedures (Consolidating Procedures) which have been changed (Changed Procedures) through previous consultations (Previous Consultations), to enable the National Electricity Amendment (Wholesale Demand Response Mechanism) Rule 2018 No. 9 Rule (WDR) under the National Electricity Rules (NER).

AEMO is conducting the Consolidation Process in accordance with NER 7.16.7(e).

Relevant Matter

AEMO is conducting the Consolidation Process to consolidate the Changed Procedures into the Consolidating Procedures, to enable the Wholesale Demand Response Mechanism.

The Consolidation Process does not involve any substantive amendments to the obligations in the Consolidating Procedures.

AEMO undertook the Previous Consultations in respect of the Changed Procedures in 2020, in accordance with NER 8.9.

The Consolidation Proposal is detailed in the amendment paper (Amendment Paper)which is published with this Notice.

- Note that submissions which AEMO receives after the closing date and time will not be valid, and AEMO is not obliged to consider them. Any late submissions should explain the reason for lateness and the detriment to you if AEMO does not consider your submission.
