Is there an alternative initial population option you believe would better achieve the desired objectives?	Not specifically. Alinta still believes this information can be captured by certain B2B transactions that AEMO would need to interrogate via the B2B hub.
What do you believe should be considered in implemented your preferred initial population option?	Alinta believes a compliance holiday post November 2023 for tier 2 retailers should be considered since this obligation on CDR activities does not begin until November 2023 for tier 2 retailers.
