

NOTICE OF FIRST STAGE OF CONSULTATION

National Electricity Rules - Rule 8.9

Amendments to System Strength Requirements Methodology, System Strength Impact Assessment Guidelines and Power System Stability Guidelines

Date of Notice: 26 April 2022

This notice informs all Registered Participants and interested parties (Consulted Persons) that AEMO is conducting a consultation on amendments to the System Strength Requirements Methodology and System Strength Impact Assessment Guidelines, as well as consequential changes to the Power System Stability Guidelines. This consultation is being conducted under clauses 5.20.6, 4.6.6 and 4.3.4 of the National Electricity Rules (NER), in accordance with the Rules consultation requirements detailed in rule 8.9.

Matter under consultation

AEMO is consulting on a proposal to amend the current System Strength Requirements Methodology¹ and System Strength Impact Assessment Guidelines² to reflect recent rule changes³ relating to the system strength framework, and make any other necessary improvements to those instruments to facilitate the application of the framework. The Power System Stability Guidelines are likely to require relatively minor changes to recognise the system strength framework.

In accordance with clause 11.143.2 of the NER, AEMO is required to publish the amended System Strength Requirements Methodology and System Strength Impact Assessment Guidelines by 1 December 2022.

In your submission, you may request a meeting with AEMO to discuss the matter under consultation, stating why you consider a meeting is necessary or desirable.

If appropriate, meetings may be held jointly with other Consulted Persons. Subject to confidentiality restrictions, AEMO will generally make details of matters discussed at a meeting available to other Consulted Persons, and may publish them.
