3. Program Update – G. Windley (Slide 5)

Transparency on AEMO's external architecture was requested which has traditionally, only been provided regarding impacts on external stakeholders.

Action 5.3.1. Understand what AEMO are prepared to share with the industry with regard to internal architecture – G. Windley

The impact of AEMO's DER program overlapping with 5MS is being looked at presently. The reference to DER in the meeting pack is to the DER Register and not the entire DER Program.

Market trials will commence from Dec 2020 to May 2021. The original sandbox environment will go ahead with further details to be determined closer to these dates. Ramp ups would need to be discussed and a decision on how AEMO's support will need to be decided upon. All functionality will go in as per the current schedule. AEMO's systems will be ready on 1 July, however Victoria may have an opportunity to have a slower ramp up.

Monday's Metering FG discussed the process. Contact Emily Brodie for further information.

4. Industry Risks & Issues – G. Windley (Slides)

R06 and R09 – discussion with forum concluded both risks are to remain, however risk 6 is to be rewritten to be about timeline slippage and responsibility escalated to the EF.

5. Procedures Work Stream – E. Brodie (Slides 10 & 11)

Metering procedures changes – Package 1 was released last week. Submissions close 28 December giving stakeholders more time to make submissions beyond the minimum requirement and also allowing AEMO time to respond within its maximum timeframe

Next week's Metering FG will discuss issues pertaining to Package 1. On the release of the Consultation AEMO notified industry via their website, an AEMO Communications mail out and a separate email sent Friday to 5MS CRM groups. Participants were encouraged to email 5ms@aemo.com.au if there are any queries.

Focus Groups names will no longer be called "Joint" as they are all integrated with the Systems work. The "Joint" and "Systems" will be removed from the name for simplicity.

A rundown of the Procedure tracking was given.

6. Systems Work Stream – H. McNeish (Slides 13-14)

Web interface was reviewed in the Dispatch FG. Discussion has been had on P5 and the Group are looking at extending this. Please send any feedback to be included in the



discussion.

AEMO needs to implement a 30-minute PASA as it is required under the rule. Industry would need to put in a rule change for 5 Minute to be included.

Action 5.6.1 Distribute Dispatch FG to be distributed to PCF notes where this was discussed and ensure they are included on AEMO's website. E. Brodie

The SWG Meeting focussed on the new bidding format, conferred on the end-to-end sandbox environment (schedule for this is to be determined), enabling testing earlier in participant's own environments prior to getting into official testing.

The SWG to be held on 21 Nov will look at a high-level impact assessment, planned schedule, Web API's and review the position of the joint focus group.

7. Stakeholder Update (Slide 16)

5MS and Global Settlements factsheets are to be released shortly, along with the summaries of one on one meetings in the next two weeks.

Participant were encouraged to complete the Stakeholder Engagement Survey here.

2019 proposed meeting calendar up to July has been circulated to 5MS Groups.

Matters for Discussion

8. Update of Drafting Amendments (Slides 17-21)

AEMO's rule change request to amend problematic areas.

Item 1 – Typographical errors – Closed.

Item 2 – AEMO using 5 Minute data to calculate MLFs – Rule change to be requested (Required by 1 Jul 21).

Item 3 - Soft cutover - no feedback received.

Item 4 – 5-minute pre-dispatch – Rule change to be requested (prior to 1 Jul 2021).

Collation of amendment list will continue until December 2018 and only includes areas of the rules requiring amendment to make 5MS function.

Feedback set out to be differentiated between procedures and rule changes to provide clarity.

Action 5.8.1. AEMO to investigate how co-ordination to occur across workstreams. C. Muffett

Expedited rule change process (2 months) will be used if possible.

No need for a rule change for pre-dispatch sensitivities as they are not precluded in the NER.

9. Update on non-mandatory components – C. Muffett (Slides 22-24)

Non-mandatory items are items not directly required to implement 5MS.



Timelines – some work completed, however further details are required and will be bought to the next PCF.

Items 1, 2 and 3 - Unify meter data delivery – part of Metering Package 1 outlines AEMO's position and is subject to consultation and awaiting feedback.

Item 4 – Overhaul dispatch interface – SWG and Dispatch Focus Group are providing feedback. AEMO is proceeding based on a technology change.

Item 5 – Energy Storage System changes – no impact on 5MS.

Item 6 – Decommission sample meters – not appropriate for AEMO to presume this as part of 5MS. Arrangement for both 5-minute and 30-minute profiles, however primary responsibility belongs to jurisdictions. To be removed from list.

Item 7 – Reallocation – scope of reallocation may involve different options to be considered. To be discussed at Settlement Focus Group on 26 Nov.

Incremental Timeline – benefits of change beyond what is needed for 5MS and weighing up against timeline impacts to AEMO will be what the recommendations are based on.

Further updates will be provided at future PCFs.
