AEMO Competition Law Meeting Protocol

AEMO is committed to complying with all applicable laws, including the Competition and Consumer Act 2010 (CCA). - 1. Which customers they will supply or market to
- 2. The price or other terms at which Participants will supply
- 3. Bids or tenders, including the nature of a bid that a Participant intends to make or whether the Participant will participate in the bid
- 4. Which suppliers Participants will acquire from (or the price or other terms on which they acquire goods or services)
- 5. Refusing to supply a person or company access to any products, services or inputs they require

Under no circumstances must Participants share Competitively Sensitive Information. Competitively Sensitive Information means confidential information relating to a Participant which if disclosed to a competitor could affect its current or future commercial strategies, such as pricing information, customer terms and conditions, supply terms and conditions, sales, marketing or procurement strategies, product development, margins, costs, capacity or production planning.

AEMC final determination on delayed implementation of 5MS and GS Rule change proposal and AEMC conclusions

In the context of COVID-19 and the market bodies' work to prioritise regulatory reform processes, AEMO proposed to delay the start of 5MS and GS by 12 months.

The rule change was assessed on an expedited process.

AEMC conclusions:

- COVID-19 has had a short term impact on industry capabilities to implement 5MS and GS and meet business activities to supply energy and support customers.
- These COVID-19 impacts have put a strain on participant capabilities, slowing or delaying their 5MS and GS implementation programs.
- The impact of COVID-19 on industry capabilities was only in the order of two to three months and participants have so far had a number of years to implement each of the 5MS and GS reforms.

AEMC final determination on delayed implementation of 5MS and GS Reasons to delay by 3 months

The AEMC considered that a 12 month delay was too long. It would:

- create cash flow benefits from deferring implementation expenditure, however 5MS and GS project costs would increase and overall industry cash flows are expected to be worse than not delaying 5MS and GS.
- not impact participants equally, with those participants that are more progressed with their implementation being more adversely impacted by a delay than those that were less progressed.
- delay the realisation of short-term efficiency benefits associated with 5MS and GS.
- not be an efficient or targeted way to address specific cash flow issues that a sub-set of participants may have. As such, it would not materially assist in avoiding potential financial contagion from COVID-19.

The AEMC decided that a shorter delay of three months to the start of 5MS and GS would:


- recognise the short-term impact of COVID-19 on participant capabilities
- not significantly increase or decrease 5MS and GS implementation costs
- not materially reduce the broader market and consumer benefits from the rules.



Summary of Impact

- AEMO 5MS Program will continue to progress with system development and deployments to meet the current milestones
 - Platform release of MDM, Settlements and 5-min Bidding into 5MS Staging Environment, AEMO pre-production environment and production will remain as scheduled
 - The details of when each piece of functionality will be discussed through the RWG/SWG and will be shared on 13-Jul-20
- Industry Readiness activities (participant testing and transition) will change to accommodate the new rule commencement dates to be discussed during this session
- Extension of the 5MS Staging Environment is under consideration
- Reallocations update will be needed with new 5MS commencement date plan will be communicated through RWG/SWG
- Working Groups will remain on a monthly basis until 5MS go-live with focus groups being used as needed
- Working Groups/ Focus Groups used as needed up until GS go-live
- 5MS mailbox will remain active until GS go-live

INDICATIVE effect of 5MS/GS deferral on procedures (1)

- New effective dates are likely the only impact to those procedures already updated for 5MS/GS
- Final determination indicates that AEMO can change the effective date of already-determined procedures (updated for 5MS and GS) without further consultation.

Next steps

Use AEMO's BAU processes to:

- 1. Review each of the 5MS and GS affected documents
- 2. Assess the need for a consultation process
- Advise the industry of the outcome of the assessment of need for a consultation process
- 4. Make any necessary changes to affected documents
- 5. If necessary, consult in accordance with clause 8.9 of the Rules (or other clauses as relevant).
- Will advise on timeframes for each step at the August RWG/SWG (now that key 5MS/GS dates have been confirmed), accounting for any flow-on impacts to transition planning.
- In addition to using BAU engagement channels, AEMO's 5MS program will communicate procedure change information through a log presented monthly to the RWG/SWG.





Summary of Impact on Approach to Transition



Phased implementation approach is maintained:

- Platform go-lives to deliver require capabilities
- 5MS and GS implementations aligned to Rule Commencement



Limited impact to Transition timeframes and windows:

- Shorter deferral has reduced the need for a "2 speed" transition
- Bidding transition period extends from 1 Apr to 1 Oct 2021
- Transition approach will continue to support commencement of transition activities as early as possible (subject to appropriate counter party agreements)



Metering Transition:

- Plan to be revised to take into consideration new Rule Commencement requirements
- Participants plans may need to be revised, with progress reported against new timings
- Participant accreditation timings to be reviewed



Summary of Impact on Market Trials and Readiness Reporting



Industry Testing and Market Trials:

- Market Trials realigned with revised Rule Commencement dates
- Staging environment to be utilized for participant testing of all releases, in mode agreed with Industry
- Industry tests for platform deployments as per current strategy



Readiness reporting:

- Participant special survey issued to provide the Executive Forum a consolidated view of participant impacts associated to the Rule Change request process and outcome
- Cadence of planned Readiness Reporting to be maintained
- Participants expected to report against their updated plans i.e. reflective of the revised Rule Commencements

Context

Background

- Transition Focus Group reviewed the MTP at its 6th May meeting to understand what effects a delay may have on the plan
- Broadly speaking, nearly all MTP activities would shift by the duration of the deferral

Key Inputs/Assumptions

- Final determination timings
 - 5MS commencement date 1 Oct 2021
 - GS "soft" start date 1 Oct 2021

- AEMO will take the following measures internally to reduce the risk:
 - Identify shared resources and establish dedicated personnel in place
 - Minimise/re-schedule AEMO-wide BAU changes during the "cutover" period
 - Bring forward compatibility testing of key interfaces (i.e. RM40 file) to the maximum extent possible
 - Bring forward production deployment of any components to reduce the "go-live footprint", where possible and overall go-live risk is not increased (currently being executed for Dispatch).
- Changing dates (either bring forward or push back) is not the preferred option, however:
 - Dispatch and Settlements system capability deployments do not result in immediate actions for participants (noting the potential for a mandatory data model uptake if they are split, which would need to be understood and discussed if so); and
