

SWG #19 Update

5MS Metering Procedures Updates

- Slides presented outlining 5MS/GS related Procedure Change Log. The slide pack is available here.
- There **may** be a need for a Procedure change consultation for 5MS and GS metering procedures if issues emerge through Readiness and implementation activities.
 - Metrology Procedures would require a six month consultation commencing in 1 Oct 2020 and to be completed by 1 Apr 2021 for 1 Jul 2021 effective date.
- There will be a need to do a "wash-up" consolidation of procedural changes for 5MS/GS and other changes separate to 5MS/GS. "Wash-up" consolidation can occur with a short-form consultation as each separate change will have already been consulted on.
- AEMO and participants will monitor potential procedure changes via 5MS forums, B2B, ERCF and, importantly, via 5MS readiness reporting

aseXML schema changes

- Technical design and schema drafts for Customer Switching and 5MS have been competed. ASWG consultation process will continue over the next 2-3 months.
- Release schedule is dependant on Customer Switching Go-Live date which will be confirmed by 8 March 2020.

Retail Stream updates

- <u>Timelines</u> B2M via API and Metering solution Pre Production and Go-Live dates adjusted.
- <u>Tech Spec</u> File Format & Load Process re-opened due to ERCF and B2B IEC consultations.

Settlement & Billing Technical Specification updates

- As detailed in the Technical Specification, session discussed Settlements Direct, which allows
 participants to access data, subscriptions, message delivery logs and calendars to the EMMS
 Wholesale Market System.
- Settlements Direct is a web-publishing application providing participants with access to reports and statements published by AEMO.

Data Model for Settlements and Dispatch

- <u>Data Model</u> 4.30 released into Pre-Production for Reallocations release, testing continues on 5.0 to accommodate changes regarding Price, Settlements Data and Billing Run.
- <u>Incremental Releases</u> Staging environment Participant Data Model (PDM) is a cut down version that will be released for Pre-Production (Nov 2020). We'll only utilise the Command Line Interface (CLI) installer.
- These are and will be available within the release folder under 5MS for Staging and the usual location for Pre-Production.
- Participants have been provided with instructions on how to upgrade or patch the revised data model should they wish to not reinstall.
- Details are available within the slides within above link.

Staging Environment Update

- Settlements Package 3 is due to be deployed in the 5MS Staging Environment 16 March 2020.
- The initial deployment will be configured for 30-minute settlement only, with transition to 5-minute trading intervals and global settlement to follow.
- The functions being made available are:
 - Prelim, Final, and Revision Settlements
 - Invoicing (Tax Invoice, RCTI, Adjustment Note, etc)
 - Reconciliation reports (SR, SS, etc)
 - Data Interchange
 - Settlements Direct (Production version, no API's)
- The environment will initially use a data snapshot from the EMMS Production system, taken in early February 2020. Integration with the Dispatch and Reallocations staging environment will not initially be on offer.
- 5-minute metering and UFE data will be artificially created for the staging environment.




