Proposed Industry Deferral

- On 6-Apr-20 the Market Bodies (AEMO, AEMC and AER) wrote to the COAG Energy Council to advise them that, in light of the impact of Covid-19, it is proposed:
 - Industry be provided with a 12 month delay to five-minute settlement implementation
 - The AEMO program will progress internally as planned
 - AEMO will prepare a rule change required to give effect to this change and submit to the AFMC
- Next steps:
 - AEMO is currently drafting a rule change to be submitted to the AEMC as a matter of priority
 - AEMO will keep market participants informed through the usual 5MS channels



Coronavirus (Covid-19) Risk

- Risk was raised at March PCF in relation to the impact Covid-19 may have on Industry's and AEMO's 5MS and GS implementation programs
- Risk was discussed at Executive Forum in March and the following actions were taken:
 - Risk to be monitored through PCF

- Purpose of today's discussion:

 - AEMO update
 - Participants' experiences, mitigation measures and expected impacts
- AEMO will update Industry Risks and Issue Register and publish

AEMO Costs – Cost Recovery Recap

- 'Declared NEM Project' mechanism for recovery of AEMO 5MS costs
 - Enables a bespoke approach to cost recovery which may be more appropriate than utilising existing AEMO fee recovery mechanisms
 - Requires a consultation process, which provides a formal opportunity for participants to have their views tabled and considered
- 2 Stage consultation process required under the Rules
 - Stage 1: The Project meets the criteria to be classified as a 'declared NEM Project' (sect 2.11).
 - Stage 2: The Participant fees, including the structure, start date and duration of recovery
- Stage 1 Consultation: Declared NEM Project Classification
 - Must be a major reform, major change to AEMO role or major upgrade of IT systems
 - Consultation on Stage 1 was completed in November 2019
 - AEMO concluded that the 5MS/GS reforms meet the criteria to be a declared NEM Project



AEMO Costs – Stage 2 consultation approach and timeline

- Stage 2 Consultation Declared NEM Project Fee Approach
 - > Sets out the fee recovery approach e.g. structure, start date, duration
 - ➤ Must consider 5 key principles: simplicity, recovery of CAPEX and OPEX, reflect the beneficiary, not unreasonably discriminate, ancillary service providers treatment
 - ≥ 2 step consultation process again required.
- Co-ordinated approach with AEMO July 2021 fee re-set process
 - > 5MS declared NEM project consultation to run on the same timeline as the AEMO July 21 fee reset process
 - > They will be run as separate consultations (i.e. separate consultation papers) but will be co-ordinated
 - > It may be necessary to cross reference between the two papers, this will occur as required
 - > An aligned timeline is expected to provide the most efficient response approach for participants.
- Key dates
 - ➤ Initial consultation paper published July 2020. Consultation open for ~8 weeks, responses due Sept 2020
 - ➤ Draft report published November 2020. Consultation open for ~8 weeks. (Dependent on feedback to initial consultation)
 - > Final report published March 2021
 - > Fee structure takes effect 1 July 2021
 - ➤ AEMO obliged to provide 3 months notice period before fees commence.

Program update and current activities



AEMO program

- Overall Amber, pressures emerging in the development of Metering.
- The AEMO Internal Metering Solution milestone "Build complete" is at risk for the 30 June 2020.
- Re-planning exercise is in progress and is in its final stages.
- At this stage we see no change to the overall delivery dates which impact participants.



Systems

- 5MS Reallocations successfully deployed in Production 01-04-2020, completed by a remote deployment team.
- Staging environment updated with Settlements Package 2 and combined Dispatch and Settlements Data Model Released 16 March 2020.



Readiness

- Industry Readiness Report Round 1. Participant Follow up in progress. Round 2 survey to be issued 14 April.
- Initial meter installation plans for T 1-3,4* configuration being consolidated.
- ITWG has commenced planning for Participant testing for MDM release.


Issues impacting the delivery of milestone L1-M6

- Increase in complexity of the solution (under-estimation of effort in some areas)
- Technology issues which have impacted on productivity
- Security
- COVID-19

Mitigation & Consequence

- Functionality required for AEMO Metering solution go-live on 7 Dec 2020 will be prioritised and delivered on time by 30 June 2020.
- Functionality not essential for 7 Dec 2020 will be completed after 30 June 2020 a new milestone will be added to track this.
- This strategy is intended to enable AEMO Metering Solution go-live to continue as scheduled on 7 Dec 2020, with a second internal AEMO drop in Feb 2020.
- On this basis, no impact to participants and no consequence to participant dates.
- Note: Re-planning currently being finalised to validate this, if there is change the PCF will be advised.

SWG #20 Update

Rejection of Metering Data sent by an MDP not in a MDP Role

- Original proposed solution within the new MDM implementation is for AEMO to accept B2M MTRDs for NEM Settlements, effectively a system solution to Market non-compliance scenarios.
- AEMO current position is to revert to the Procedure.
- Discussed at Transition Focus Group 06-April-2020 and next steps are being followed up as a matter of priority.

Participant ID Update for GS

- To support the Global Settlement (GS) changes all Distribution Network Connection Points will have their Local Retailer (LR) participant id updated to "GLOPOOL".
- AEMO's solution is to update the required LR and FRMP code without sending Market Notifications. Market Participants will be required to update their own systems at <u>GS go live</u>.



5MS Release 1: Reallocations

- PROD Cutover completed 1 April 2020.
- Issues & Resolutions:
 - Identified a DB scripting error arising from Tuesday's DB changes to add two new columns in the database. Once the script was run the issue was resolved in a timely manner without impacting Compliance for either AEMO or the participant.
 - A second issue arose when the Prudentials run failed to start following the Reallocation. The fix was then deployed in production at 2pm Wednesday 1 April 2020. No further issue during Thursday's BAU activity in production.
 - During PVT there was an API Service configuration error (Supplied Reallocation ID not Valid) due to the Reallocation system. Fixed immediately and the PVT test completed successfully.
 - On Thursday 2 April 2020, a participant identified a label error that was showing 'MWH' instead of '\$' in a preview reallocation pop-up. The actual values are correct but the heading has the wrong label. To be fixed in the next software deployment.

Staging Environment Update

- Settlements Package 3 be deployed in the 5MS Staging Environment 16 March 2020. So far:
 - Successfully run 2019Wk24 Final
 - Successfully run 2019Wk25 Final
 - Produced Tax Invoices, RCTI's, Statements, and Reconciliation (SR, etc) reports for both runs
 - Produced Data Interchange files for both runs
 - Identified an integration issue between Settlements Direct and Invoicing
 - The invoicing engine has been updated and a new version tested + released into the Staging environment
 - Some ongoing work is still required on Settlements Direct to finalise the issue.
 - Until this issue is finalised, SR reports will not be available on the Settlements Direct portal without manual intervention
 - All other reports (Tax Invoice etc) are available on the Settlements Direct portal
- Multiple Q&A sessions held with market participants. Discussion & Questions heavy at the start and reduced later.
- Usage of Dispatch and Settlements functionality has increased.

Customer Switching

- The Final Determination on Customer Switching in the NEM was published on 31 March 2020.
- Amended procedures were published alongside the determination, including:
 - MSATS CATS
 - MSATS WIGS
 - MDFF Specification (NEM 12 and NEM 13)
- Key Points to note:
 - AEMO elected not to provide an effective date for these changes.
 - The effects of COVID-19 will continue to be monitored.
 - Once determined, AEMO will communicate the effective date no less than eight months in advance.
- In addition to the changes to support the outcomes of the Customer Switching in the NEM consultation, the MSATS procedures have been redesigned such that:
 - Technical requirement specifications are moved into an independent technical document.
 - MSATS CATS and MSATS WIGS are simplified to contain business process, rights and obligations.
