### 5 June 2025 Release

### Frequency Performance Payments (FPP)

- The overall project status is Green. AEMO provided members with an update on activities since January 2025 and a general progress summary (refer to slide 13).
- AEMO intend to issue an invitation to a March session which will provide an overview of observed outcomes in the first 6-8 weeks of NFO.
  - The event will be held on Monday 24 March 2025, 11am-12pm Melbourne time. Register here
- AEMO is yet to receive a ruling from the ATO regarding the GST treatment of FPPs.
- AEMO will shortly publish Draft updates to the Frequency Contribution Factors Procedure (FCFP) that will be progressed through a single stage consultation.

#### **SCADA Lite**
