Preliminary Matters

1. Welcome – S. Wainrit

Attendees were welcomed to Systems Working Group #16 (SWG). Introductions and confirmation of attendees.

2. Meeting notes and actions – S. Wainrit (slides 3 - 4)

Actions and updates are included in the table at the end of the meeting notes.

2. Managing emerging 5MS/GS procedures issues - Emily Brodie (slides 5 - 6)

AEMO confirmed approach (BAU channels) to managing procedural issues now that the procedures workstream is in hibernation.

Member mentioned risk in handing off to BAU channels, due to those channels not being part of the 5MS journey.

AEMO stated that the same people ultimately consider the proposed changes in the business units e.g. Settlements and Metering teams.

Member still thinks that this might impact ERCF discussions/considerations.

AEMO recognises the issue but might be too problematic.

A different Member mentioned that ERCF packs are not providing a sufficient link to 5MS program impacts. Also concerned that any change now impacts finalised requirements which may result in changes to vendor requirements.

Members are looking for better coordination pre ERCFs and B2BWGs to call out and consider 5MS related items.

2. Level 1 & 2 Milestones Timeline – S. Wainrit (slides 7 - 8)

AEMO highlighted that the milestones timeline is current as at last week

3. Retail stream update – J. Agelopoulos (slides 9 - 11)

AEMO highlighted there was not much to update this month.

- 5MS Staging Environment drop on track for 1 Dec 2019.
- MSATS Tech Spec feedback to be discussed today and corrections to be sent out early next week.
- 31 July 2020 functionality on track, interim functional drops still being considered.
- There will be some clean up activity in the new year to consider if some of these L2s should go into the Readiness workstream e.g. market trials.



4. Retail functionality available in 5MS Staging Environment – J. Agelopoulos (slides 12-13)

AEMO recapped functionality to go into 5MS Staging Environment on 1 Dec 2019.

Member, when will 15min functionality be released to 5MS Staging Environment? AEMO, functionality will come shortly but not part of 1 Dec 2019 drop.

AEMO discussed assumptions and constraints. Emphasised static standing data constraint.

Member asked if this functionality is only about delivery of metering data to AEMO from MDPs. AEMO response, correct.

Member asked if B2B message exchange will ever be supported in 5MS Staging Environment. AEMO response, not planned for at this stage.

AEMO mentioned the Staging Forums that have commenced.

5. MSATS 46.96 Technical Specification feedback – S. Tu (slides 14 - 17)

AEMO's MDM won't make use of this B2B "Role" value.

AEMO will not validate it i.e. AEMO shall ignore it. AEMO will not store this value.

MDPs can put whatever role they wish to support their own processes.

Field is a mandated procedure requirement but not a schema mandated field.

Member initially suggested populating the field with "AEMO"

AEMO needs to reopen Tech Spec due to schema change requirement.

6. 10MB file size – S. Tu (slide 18)

AEMO provided update on B2BWG/IEC considerations re file size and transaction limits.

IEC final decision will be considered by AEMO and if it deviates from the current version of the MDM File Format and Load Process document, this document will need to be updated to reflect the IEC decision.

Member question: how will 10MB be defined.

Participant mentioned performance considerations due to shift to 10MB

8. aseXML schema changes – S. Tu (slides 21 - 25)

AEMO provided context and approach to managing the identified schema changes.

Member asked who was responsible for population of TNI2? AEMO response, AEMO in conjunction with the LNSP.

Member asked if this means a new field is being introduced into MSATS? AEMO response, yes, that is what is being proposed.



How Multi Use NMI information will be displayed in MSATS is still being considered.

Discussion regarding the interplay and timing of potential Customer Switching schema changes.

9. Dispatch stream update – I. Devaney (slides 27 - 30)

Web bidding user guide delayed to 16 Dec 2019
