Aggregated Dispatch Conformance (ADC) Summary

 AEMO provided a summary on ADC and advised that industry test is currently underway and progressing well. AEMO noted that registration opens from 9 August 2023.



Fast Frequency Response (FFR) Approach

(Slides 10-13)

- AEMO highlighted activities for FFR industry testing with detailed information and key dates available on slide 11 of the accompanying slide pack. An industry test timeline was presented and is available on slide 12 of the accompanying slide pack.
- AEMO highlighted that Registration process is for Production provision of VFast FCAS, with an interim step being the provision of pre-prod access, which will support participation in Industry testing
- AEMO outlined the FFR industry testing approach with detailed information available on slide 13 of the accompanying slide pack.

5MLP Approach (Slides 14-17)

- AEMO outlined the 5MLP industry testing approach and noted testing will run from 4 September to 28
 September 2023 with detailed information outlined on slide 15 of the accompanying slide pack.
- AEMO advised that twice-weekly Q&A sessions will be issued to participants to support industry testing and discuss any issues encountered. Sessions will coincide with the FFR Q&A.

MT PASA Approach (Slides 18-21)

- AEMO outlined the MT PASA industry testing approach and noted testing will commence on 28 August to 29 September 2023 with detailed information outlined on slide 19 of the accompanying slide pack.
- AEMO advised that twice-weekly Q&A sessions will be set up with participants to support industry testing and discuss any issues encountered.
- AEMO summarised key dates associated with the MT PASA industry testing and are outlined on slide 20
 of the accompanying slide pack.

November Release (Slide 23)

- AEMO outlined the November release industry testing approach and included the industry test approach
 for CDR, MSDR and Metering Exemptions with detailed information outlined on slide 23 of the
 accompanying slide pack.
- AEMO noted that industry test window is set for 2 October through to 27 October 2023 and noted that AEMO are assessing options to make APIs available at an earlier date to increase the industry test window.
